ELIGIBILITY REQUIREMENTS

A) Player is eligible if they have not turned 19 years of age prior to May 1st in the calendar year of competition. Player must be a high school student pursuing a high school diploma. Player cannot be a high school graduate and must be living with a parent or guardian.

B) A player has four consecutive years of combined varsity and sub-varsity eligibility (Junior Varsity, Freshmen team, etc.). The four consecutive year clock begins with participation in any varsity or sub-varsity sport, even if they repeat a grade. Player cannot change or reclassify grade level to increase eligibility. Player who has exhausted four consecutive years of combined varsity and sub-varsity participation in any sport is ineligible for a 5th year of eligibility in football.

• Participation on a middle school team does not count towards the four combined years of varsity and subvarsity eligibility.

• Teams may designate middle school players for participation in a combined middle school and sub-varsity (Junior Varsity, Freshmen team, etc.) team without starting the four consecutive year clock. This designation must take place at the time of initial participation.

• Underage players are allowed to play up for either varsity or sub-varsity for teams that do not have more than 24 players on their roster. Participation will not count towards the four consecutive combined years of varsity and sub-varsity eligibility if they are designated as an underage player at the time of initial participation.

C) Player must be engaged in a homeschool or school education curriculum managed by the parent or guardian, teacher, or school administrator. Taking dual credit or college classes is acceptable provided that a player has not graduated from high school.

D) All players must submit the NHFA eligibility form annually certifying eligibility status through a parental signature. Players must submit a school transcript and/or homeschool transcript when initially establishing eligibility.

• Homeschool players must submit a transcript once when establishing eligibility but need not submit one in subsequent years.

• Non-homeschool players must submit a transcript annually.

• Player cannot play in a game until all eligibility forms including transcripts are submitted and approved by the NHFA establishing eligibility.

E) A non-homeschool player is defined as a player who attends a public, online, charter, or private school outside the home more than 3 days a week. Teams are limited in the number of non-homeschool players they can have on their team. 40% non-homeschool for rosters above 24, 50% for rosters with 24 or less players.

• Non-homeschool players must provide a school transcript alongside their NHFA eligibility form annually to certify eligibility.

• Non-homeschool players that are academically ineligible at their current school are not eligible for competition.

• Non-homeschool players that are under discipline at their current school are not eligible for competition but may file a hardship waiver if the discipline is demonstrably egregious.

F) First Year Seniors:

• Non-homeschool players without access to a football program through their school are eligible and must submit NHFA eligibility form and transcripts.

• Existing homeschool athletes are eligible to participate for the first time as a senior and must submit NHFA eligibility form and transcripts.

• First year public/private school seniors with access to a football program through their school are ineligible but may submit a hardship waiver request based on a change of life circumstance.

G) Transfers

• Homeschool players may transfer between programs but are strongly encouraged to leave on good terms with their previous program.

• Non-homeschool players may transfer provided they meet all other eligibility requirements.
